At the Giving Tree Foundation we are committed to respecting your privacy and protecting your personal information. Our promise to you through our Privacy Policy is that:

- We will be transparent about the information we are collecting and what we will be doing with it
- We will use the information you have provided us for the purposes detailed in our Privacy Policy.
- If you no longer want to receive nay messages from us, just let us know and we will remove your details from our system. Upon being removed from our system you will receive one final message from us confirming that we no longer hold any of your data.
- We already have in place measures to protect your information and keep it secure.
- We will always respect your data protection rights and aim to give you control over your own information.

This Privacy Policy governs the manner in which The Giving Tree Foundation collects, uses, maintains and discloses information collected from users (each, a "User") of the http://www.thegivingtreefoundation.co.uk website ("Site").

Personal identification information

We may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our site, place an order, fill out a form, and in connection with other activities, services, features or resources we make available on our Site. Users may be asked for, as appropriate, name, email address, mailing address, phone number. Users may, however, visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personal identification information, except that it may prevent them from engaging in certain Site related activities.

Non-personal identification information

We may collect non-personal identification information about Users whenever they interact with our Site. Non-personal identification information may include the browser name, the type of computer and technical information about Users means of connection to our Site, such as the operating system and the Internet service providers utilized and other similar information.

Web browser cookies

Our Site uses "cookies" to enhance User experience. The User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. Users may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. If they do so, note that some parts of the Site may not function properly.

The Giving Tree Foundation Site uses 3 cookies:

- A session cookie comprised of a random string of characters used to identify the visitor. This contains no personally identifiable details. This cookie expires when the browser is closed.
- 2. We use a cookie to remember if the User has closed the newsletter subscription box or not. It expires after 24 hours.
- 3. We use a cookie to remember if the User has closed the cookie law box. It expires after 24 hours.

How we use collected information

- 1. The Giving Tree Foundation may collect and use Users personal information for the following purposes
- To run and operate our Site
- 2. We may need your information to display content on the Site correctly and to improve our Site.
- 3. We may use feedback you provide to improve our products and services.
- To run a promotion, contest, survey, or other Site feature.
- 4. To send Users information they agreed to receive about topics we think will be of interest to them, through periodic emails
- 5. We may use the email address to send User information and updates pertaining to their order. It may also be used to respond to their inquiries, questions, and/or other requests.
- To comply with our obligations under any applicable law, or in order to enforce or apply our terms of use.

We <u>do not</u> store credit card details nor do we share customer details with any 3rd parties.

How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our Site. The data that we collect from you will be transferred to, and stored at, a destination inside of the European Economic Area ("EEA"). All information that you provide to use is stored on our secure servers. Any payment transactions will be encrypted [using SSL technology].

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our Site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

Sharing your personal information

We do not sell, trade, or rent Users personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners, trusted affiliates and advertisers for the purposes outlined above.

Electronic newsletters

If User decides to opt-in to our mailing list, they will receive emails that include company news, updates, related product or service information.

Third party websites
